1. This event is promoted by the Wellington Triumph Sports Car Club Inc. under the MotorSport New Zealand Inc. National Sporting Code its applicable Appendices and Schedules, the Standing Regulations for all ClubSport Events (as contained in Appendix Five - Schedule C) and these Supplementary Regulations.

3. The MotorSport NZ permit for this meeting is *tba* and is for a Clubsport Advanced Event (Bent Sprint (Single Car)).
4. The Competition will be held on **Sunday 14 October 2018** on Coast Road, Wainuiomata. There will be a driver's briefing, with roll call at 8.00am at the East Harbour Regional Park Bridge. **Attendance is compulsory.** Competition will commence after the road closure, which begins at 8.30am.
5. Scrutineering and documentation as per Schedule A or AA of the current NZ Motorsport Manual will be:

From:	from 3pm to 5pm on Saturday 13 th October 2018
And:	at the venue from 7am to 8am on Sunday 14 th October.

Competitors are strongly encouraged to attend scrutineering and documentation on the Saturday afternoon.
6. Any competitor "drifting" on any of their runs will be excluded from the event immediately.
7. The venue is Coast Road, Wainuiomata. Access prior to the road closure is via the northern end of Coast Road – during the road closure the only access to the southern end of the venue is by negotiation with the Clerk of The Course or via the coastal routes from the Wairarapa or Eastbourne. The surface is sealed and approximately 2.5 km in length.

Vehicle access is restricted to your competition car and a maximum of one support vehicle (and trailer) in the designated paddocks or on Coast Road – DO NOT block any gates. Remember, unlicensed vehicles must not be driven on public roads.
8. Entries open with the publication of these regulations and close at 5pm on Saturday 13th October 2018.

FEES: The entry fee is \$100.00 (no GST applicable) and MUST accompany the official application form, which is attached.

ENTRIES RECEIVED AFTER 5.00PM ON FRIDAY 12th OCTOBER 2018 WILL BE DEEMED LATE AND WILL INCUR AN ADDITIONAL FEE OF \$40.00.

Applications are to be made on the correct form and to be deemed valid must be complete in all details and accompanied by the appropriate fees. Applications can be gained from the Event Secretary.

Payment can be made by direct credit to 02-0536-0052466-00 (Wellington Triumph Sports Car Club). Please include your name and the word "Coast" in the payment.

Acceptance will be at the organising committee's discretion and as a result of meeting scrutineering requirements. The organisers reserve the right to refuse any application in accordance with the prescribed provisions of the National Sporting Code and these regulations.

Acceptance of entry will not be sent out. Unsuccessful applicants will, however, be notified.

The organisers reserve the right to abandon the event if less than 40 entries are received at the closing date. The maximum number of starters will be 50 with the option of running an additional five reserves at the discretion of the Clerk of Course on the day. Any additional entries will be placed on the reserve list.

In signing the application form competitors are deemed to fully understand the relevant articles and regulations as contained in the current NZ MotorSport Manual. This is also a declaration that the vehicle they are competing in is up to all required standards. **Please note that slick tyres are not permitted.**

ALL DRIVERS MUST POSSESS AND PRODUCE THE FOLLOWING FOR INSPECTION AT SCRUTINEERING/DOCUMENTATION:

- Current MotorSport New Zealand Competition Licence
- Current MotorSport New Zealand Affiliated Car Club Membership card
- Tyres intended for use at the events
- Log Book (where issued)

All vehicles must display the scrutineering sticker provided.

Competitors are responsible for providing competition numbers for at least the right hand side of their car, but preferably **BOTH** sides of their car. Read the minimum requirements in the motorsport manual and make them to those specifications.

If you are unable to produce competition numbers to the MotorSport New Zealand requirements, individual digits can be purchased at Saturday documentation for \$1.00 per digit but you will have to provide your own adhesive tape.

All vehicles must be presented in a clean, tidy condition.

Dual driver cars are permitted (no more than two drivers per car).

9. It is the organising committee's intention that all competitors will complete three official runs except where a competitor fails to start when requested. In that circumstance, that competitor will forfeit that run. Competitors are expected to line up without having to be asked.

For practice and each official run, half the field will run through the course. Once those cars have finished, they will tour back to the start line and the other half of the field will run.

Results will be established using each competitor's fastest official run.

10. Classes are as follows:

Eion's Index of Performance trophies will also be awarded, separate to the above classes.

11. Practice doubles as the familiarisation run and as such any driver crashing their car – or driving off the course – during their practice run forfeits any rights to anonymity within the MotorSport community.
12. Passengers will be permitted to travel in all timed and official runs. **PLEASE LET THE CHIEF SCRUTINEER KNOW AT SCRUTINEERING WHETHER YOU INTEND TO PARTICIPATE WITH PASSENGERS SO THAT YOUR CAR CAN BE SCRUTINEERED FOR COMPLIANCE.** Drivers are required to ensure all passengers wear appropriate safety equipment, which must also be available for scrutineering. Passengers must sign the appropriate indemnity form, have the chosen hand stamped (we'll let you know which hand) and **MUST** attend the 8.00am drivers briefing.
Car and passenger must comply with the requirements as set out in Schedules A and C.

13. Provisional Results will be posted at the venue during competition. A complete set of results will be available as soon as practical following the conclusion of the event.

Results will be declared final 30 minutes after being posted. Any competitor withdrawing from the event should immediately notify the Secretary.

14. All claims through the MotorSport New Zealand Public Liability Insurance have an excess of \$3,500.00. Therefore, competitors will be responsible for the recovery of their vehicle, any damage they cause to public or private property and will be liable for any associated costs that are charged to the club up to the value of this excess. Repairs will be arranged by Wellington Triumph Sports Car Club Inc. and repayment will be required within 21 days of invoicing.
15. Competitors are requested to drive considerately to and from the event. Alcohol and drugs are not permitted.

Competitors are reminded to refrain from familiarising themselves with the course prior to competition commencing, we remind you that venues in general and road closures in particular are not easy to obtain and **any abuse of this privilege will not be tolerated.**

16. Following the conclusion of the competition a prizegiving will be held.
VENUE: To be advised at Drivers Briefing.
TIME: From 4.30pm on (provided we receive help from competitors to clean up).

Attendance at prizegiving is expected.
